

## **ABSTRAK**

Tulisan ini bertujuan untuk (1) mendeskripsikan kelompok *Lepo Lorun*, (2) mendeskripsikan dan menjelaskan kontribusi *Lepo Lorun* terhadap masyarakat dalam tinjauan teori sosiologi fungsionalisme struktural.

Metode yang dipakai dalam tulisan ini bersifat deskriptif kualitatif. Objek yang diteliti adalah kontribusi *Lepo Lorun* terhadap masyarakat dalam tinjauan teori sosiologi fungsionalisme struktural. Wujud data dalam tulisan ini berupa kata dan tabel yang terdapat dalam komunitas *Lepo Lorun*. Sumber utama penelitian ini adalah komunitas *Lepo Lorun* dan buku Teori-teori Sosiologi Modern Edisi Revisi. Sumber sekunder dari kajian ini adalah perpustakaan dan internet. Teknik pengumpulan data yang digunakan adalah interaktif dan non interaktif. *Pertama*, teknik interaktif berupa wawancara baik secara langsung dengan narasumber maupun secara telepon seluler serta media sosial. *Kedua*, teknik non interaktif meliputi analisis isi terhadap buku-buku *Lepo Lorun* dan buku-buku teori sosiologi fungsionalisme struktural.

The method were used in this writting thesis is qualitative descriptive.
