

## **ABSTRAK**

Darius Lifentjing Halut 20.75.6777. **Upaya Mengatasi Kekerasan Terhadap Perempuan Di Kabupaten Manggarai Ditinjau Dari Konsep Hak Asasi Manusia.** Skripsi Sarjana, Program Studi Ilmu Filsafat, Institut Filsafat Dan Teknologi Kreatif Ledalero.

Karya ilmiah ini bertujuan untuk (1) menjelaskan fenomena kekerasan terhadap perempuan di Kabupaten Manggarai, (2) menjelaskan selayang pandang tentang hak asasi manusia, dan (3) upaya mengatasi kekerasan terhadap perempuan di Kabupaten Manggarai ditinjau dari Konsep Hak Asasi Manusia.

Penelitian untuk penulisan skripsi dilakukan dengan metode studi kepustakaan dan metode wawancara. Dalam studi kepustakaan penulis menggunakan berbagai literatur seperti, buku, jurnal, berita *online*, sumber internet, dan kamus, yang berkaitan dengan Hak Asasi Manusia. Selain analisis kepustakaan, penulis juga menggunakan metode wawancara, yakni mewawancarai beberapa narasumber untuk menggali fakta tentang kekerasan terhadap perempuan di Kabupaten Manggarai. Obyek yang diteliti dalam tulisan ini adalah relevansi konsep hak asasi manusia dalam upaya mengatasi kekerasan terhadap perempuan di Manggarai. Kekerasan terhadap perempuan merupakan pelanggaran serius terhadap hak asasi manusia. Hal ini mengakibatkan posisi perempuan dalam suatu masyarakat terancam dan mengalami diskriminasi.

Hasil penelitian menunjukkan bahwa kasus kekerasan terhadap perempuan di Manggarai dipicu oleh berbagai faktor seperti, budaya patriarki, kemiskinan, rendahnya pendidikan, dan kurangnya kesadaran hukum dalam masyarakat. Bentuk kekerasan juga bervariasi seperti kekerasan fisik, kekerasan psikis, kekerasan seksual, dan kekerasan ekonomi. Berhadapan dengan situasi ini, konsep hak asasi manusia yang menekankan kesetaraan dan penghormatan terhadap martabat setiap orang, dapat meningkatkan efektivitas program dan penanganan kekerasan terhadap perempuan di Kabupaten Manggarai.

## **ABSTRACT**

This scientific work aims to (1) explain the phenomenon of violence against women in Manggarai regency, (2) provide an overview of human rights, and (3) explore efforts to overcome violence against women in Manggarai District from the perspective of Human Rights Concepts.

The research for this thesis was conducted using literature research methods and interview methods. In the literature research, the author utilized various literature such as books, journals, online news, internet sources, and dictionaries related to Human Rights. In addition to literary analysis, the author also employed interview methods, interviewing several people to gather facts about violence against women in Manggarai regency. The focus of this study is the relevance of human rights concepts in efforts to address violence against women in Manggarai. Violence against women is a serious violation of human rights. It endangers the position of women in society and subjects them to discrimination.

The results of the research indicate that cases of violence against women in Manggarai are triggered by various factors such as patriarchal culture, poverty, low education levels, and lack of legal awareness within the community. The forms of violence also vary, including physical violence, psychological violence, sexual violence, and economic violence. In addressing this situation, the concept of human rights, which emphasizes equality and respect for the dignity of every individual, can enhance the effectiveness of programs and measures to address violence against women in Manggarai regency.
