

ABSTRAK

Penulisan karya ilmiah ini bertujuan untuk (1) menunjukkan pentingnya revitalisasi peran kependidikan orang tua dalam mengatasi kenakalan remaja di kampung Indrong berdasarkan surat Apostolik *Amoris Laetitia* (2) mengulas konsep tentang orang tua, remaja, kasus kenakalan remaja yang terjadi di Indonesia dan secara khusus kasus kenakalan remaja yang terjadi di kampung Indrong, (3) mendeskripsikan realitas pola pendidikan orang tua terhadap remaja di kampung Indrong, (4) menjelaskan tentang Surat Apostolik *Amoris Laetitia*, (5) merevitalisasi peran kependidikan orang tua dalam mengatasi kenakalan remaja di kampung Indrong. Metode yang digunakan dalam penulisan karya ilmiah ini adalah metode kualitatif dan metode kuantitatif. Objek yang dikaji adalah fenomena kenakalan remaja yang terjadi kampung Indrong dan Surat Apostolik *Amoris Laetitia*. Dengan penelitian kualitatif penulis coba membaca berbagai literatur yang dibutuhkan dan sesuai dengan tema yang dibahas, seperti buku, jurnal, kamus, dan artikel-artikel lain baik yang terdapat di perpustakaan maupun di media *online*. Sumber utama yang dipakai dalam mengerjakan karya ilmiah ini adalah Surat Apostolik *Amoris Laetitia*. Sedangkan dalam metode kuantitatif, penulis melakukan wawancara dan observasi partisipatoris.

Berdasarkan hasil penelitian, disimpulkan bahwa (1) fenomena kasus kenakalan remaja yang terjadi di kampung Indrong disebabkan oleh faktor kesalahan pola pendidikan orang tua. (2) Surat Apostolik *Amoris Laetitia* merupakan dokumen yang secara khusus berbicara tentang keluarga dan memberikan pemahaman baru tentang pola asuh dan pola didik anak oleh orang tua di lingkungan keluarga. (3) Peran kependidikan orang tua di lingkungan keluarga sangat berpengaruh dalam membentuk karakter remaja di masa yang akan datang. (4) Peran kependidikan orang tua di kampung Indrong perlu direvitalisasi untuk meminimalisir kasus kenakalan remaja dan sekaligus membentuk karakter remaja yang baik dan bermutu dengan landasan Surat Apostolik *Amoris Laetitia*.

ABSTRACT

The writing of this scientific work aims to (1) show the importance of revitalizing the educational role of parents in overcoming juvenile delinquency in Indrong village based on the Apostolic letter Amoris Laetitia. (2) review the concept of parents, adolescents, cases of juvenile delinquency that occur in Indonesia and specifically cases of juvenile delinquency that occur in Indrong village, (3) describe the reality of parental education patterns towards adolescents in Indrong village, (4) explain the Apostolic Letter Amoris Laetitia, (5) revitalize the educational role of parents in overcoming juvenile delinquency in Indrong village. The methods used in writing this scientific work are qualitative methods and quantitative methods. The object studied is the phenomenon of juvenile delinquency that occurs in Indrong village and the Apostolic Letter of Amoris Laetitia. With qualitative research, the author tries to read various literature needed and in accordance with the themes discussed, such as books, journals, dictionaries, and other articles both in the library and in online media. The main source used in doing this scientific work is the Apostolic Letter Amoris Laetitia. While in the quantitative method, the author conducted interviews and participatory observations

Based on the results of the research, it is concluded that (1) the phenomenon of juvenile delinquency cases that occur in Indrong village is caused by factors of errors in parental education patterns. (2) The Apostolic Letter Amoris Laetitia is a document that specifically talks about the family and provides a new understanding of parenting and education of children by parents in the family environment. (3) The educational role of parents in the family environment is very influential in shaping the character of adolescents in the future. (4) The educational role of parents in Indrong village needs to be revitalized to minimize cases of juvenile delinquency and at the same time form a good and quality adolescent character based on the Apostolic Letter Amoris Laetitia
