

## ABSTRAK

Fransiskus Borgias Bop Dala. *Kiprah Kerasulan Keluarga Serikat Santa Anna Paroki Santo Vincentius A Paulo Ratesuba dari Perspektif Dekrit Apostolicam Actuosiatatem dan Relevansinya bagi Penguatan Pastoral Keluarga.* Skripsi. Penelitian bertujuan, (1) menjelaskan dan mengkaji konsep Kerasulan Keluarga dalam Dekrit *Apostolicam Actuosiatatem*, (2) menjelaskan dan mengkaji Serikat Santa Anna Paroki St. Vincentius A Paulo Ratesuba serta kiprah mereka dalam kerasulan keluarga, (3) menelaah dan menganalisis kiprah kerasulan keluarga Serikat Santa Anna Paroki St. Vincentius A Paulo Ratesuba berdasarkan perspektif dekrit *Apostolicam Actuosiatatem* serta relevansinya bagi penguatan pastoral keluarga.

Penelitian ini menggunakan studi kepustakaan dan studi lapangan. Studi kepustakaan dilakukan dengan cara mengumpulkan berbagai konsep, teori, serta data-data kepustakaan dari berbagai sumber, sementara studi lapangan dilakukan dengan cara mengumpulkan data melalui metode wawancara dan observasi partisipatoris. Data-data yang telah dikumpulkan akan dianalisis dari perspektif dekrit *Apostolicam Actuosiatatem*. Objek yang diteliti adalah kiprah kerasulan keluarga Serikat Santa Anna Paroki St. Vincentius A Paulo Ratesuba.

Hasil penelitian menunjukkan bahwa berdasarkan perspektif dekrit *Apostolicam Actuosiatatem*, Serikat Santa Anna Paroki St. Vincentius A Paulo Ratesuba telah aktif berkiprah dalam karya kerasulan keluarga. Kiprah kerasulan keluarga yang telah mereka laksanakan, yakni (1) menjadi rasul bagi keluarga, (2) mengantar keluarga kepada persatuan dengan kristus, (3) membina kehidupan rohani keluarga, (4) mewartakan Kristus dalam keluarga, (5) menjalankan peran dan tanggung jawab sebagai isteri dan ibu dalam keluarga, (6) mengajarkan nilai dan keutamaan dalam masyarakat kepada keluarga, (7) mengantar keluarga untuk meneladani Santa Anna dan Santa Maria, dan (8) menjadi rasul bagi keluarga-keluarga lain. Kiprah kerasulan keluarga mereka ini memiliki relevansi bagi penguatan pastoral keluarga yakni, (1) memberikan dasar yang kokoh bagi pelaksanaan karya pastoral keluarga, (2) menjadi kelanjutan dari pastoral keluarga, (3) membantu imam dan petugas pastoral keluarga dalam menjalankan tugas dan peran mereka sehingga karya pastoral keluarga dapat berjalan efektif.

## ABSTRACT

This research aims to, (1) explain and examine the concept of family apostolate in the Apostolicam Actuositatem decree; (2) explain and examine the work of the Society of Saint Anne of Saint Vincent de Paul in the Ratesuba parish in family apostolate; and (3) analyse the work of the Society of Saint Anne of Saint Vincent de Paul in family apostolate based on the Apostolicam Actuositatem decree, and to determine its relevance in strengthening family pastoral care.

The present research employs a dual-pronged approach, encompassing both a comprehensive review of extant literature and empirical field studies. The present literature study was conducted by collecting various concepts, theories, and literature data from a range of sources, while the field study was conducted by collecting data through interviews and participatory observation. The collected data will be analysed through the lens of the Apostolicam Actuositatem decree. The object of study is the apostolic work of the family of the Society of Santa Anna of St. Vincentius A Paulo Ratesuba Parish.

The results showed that, from the perspective of the Apostolicam Actuositatem Decree, the Santa Anna Society of St Vincent A Paulo Ratesuba Parish has actively participated in family apostolic work. The family apostolic work they have carried out is (1) to be apostles to the family, (2) to lead the family to unity with Christ, (3) to promote the spiritual life of the family, (4) to proclaim Christ in the family, (5) to fulfil the roles and responsibilities of wives and mothers in the family, (6) to teach the family values and virtues in society, (7) to lead the family to imitate Saint Anna and Saint Mary, and (8) to be apostles to other families. Their apostolic work in the family is relevant to the strengthening of family pastoral, namely (1) to provide a solid foundation for the implementation of family pastoral, (2) to be a continuation of family pastoral, (3) to help priests and family pastoral agents in the fulfilment of their duties and roles so that family pastoral can be effective.
