

ABSTRAK

Cyberbullying merupakan salah satu masalah sosial yang sering terjadi di tengah kehadiran media yang berbasis internet saat ini. Masalah ini tidak hanya membawa kecemasan bagi para pengguna media, tetapi masalah ini dapat membawa pengaruh bagi kehidupan masyarakat. Untuk itu, penelitian ini bertujuan untuk (1) mendeskripsikan dan menjelaskan pengaruh tindakan *cyberbullying* di media sosial; (2) memahami dan mempelajari kembali salah satu dekret yang dihasilkan Konsili Vatikan II, yaitu dekret *Inter Mirifica*. Dekret ini lahir sebagai salah satu Tanggapan Gereja terhadap perkembangan ilmu pengetahuan, khususnya dibidang teknologi; (3) menjelaskan bagaimana upaya menyikapi fenomena *cyberbullying* di media sosial dalam terang dekret *Inter Mirifica*.

Dalam penelitian ini, metode penulisan yang digunakan adalah metode studi kepustakaan. Objek yang akan diteliti adalah masalah *cyberbullying* di media sosial dan isi dekret *Inter Mirifica*. Penulis akan mencari literatur atau sumber penelitian sebelumnya yang berhubungan dengan *cyberbullying* dan dekret *Inter Mirifica*. Berdasarkan hasil penelitian ini, penulis dapat menyimpulkan beberapa poin penting. *Pertama*, tindakan *cyberbullying* yang marak terjadi telah menggeser fungsi utama media sosial sebagai salah satu media komunikasi. *Kedua*, tindakan *cyberbullying* menandakan bahwa proses komunikasi antara individu tidak saling menguntungkan, baik komunikator maupun komunikan. *Ketiga*, untuk mencegah masalah *cyberbullying*, setiap orang harus memahami dan mempelajari kembali isi dekret *Inter Mirifica*.

Fenomena *cyberbullying* yang marak terjadi menandakan bahwa para pelaku kejahatan sama sekali tidak memahami fungsi dan tujuan utama sarana-sarana komunikasi sosial. Oleh karena itu, isi dekret *Inter Mirifica* ditawarkan sebagai salah satu upaya untuk mencegah *cyberbullying*. Nilai-nilai yang terkandung dalam dekret tersebut dapat membangun kembali kesadaran umat beriman dan semua orang tentang fungsi utama media komunikasi.

ABSTRACT

Cyberbullying is one of the social problems that often occur in the midst of the presence of internet-based media today. This problem not only brings anxiety to media users, but this problem can have an impact on people's lives. For this reason, this study aims to (1) describe and explain the influence of actions Cyberbullying on social media. (2) Understand and re-study one of the decrees produced by the Second Vatican Council, namely the decree *Inter Mirifica*. This decree was born as one of the Church's responses to the development of science, especially in the field of technology. (3) Explain how efforts to respond to the phenomenon Cyberbullying on social media in the light of the decree *Inter Mirifica*.

In this study, the writing method used is the literature study method. The object to be examined is a problem Cyberbullying on social media and the content of the decree *Inter Mirifica*. The author will look for literature or sources of previous research related to Cyberbullying and decrees *Inter Mirifica*. Based on the results of this study, the author can conclude several important points. Firstaction Cyberbullying What is rampant has shifted the main function of social media as one of the communication media. Secondaction Cyberbullying moving that the process of communication between individuals is not mutually beneficial, both communicators and communicators. Third, to prevent problems Cyberbullying, everyone must understand and re-study the content of the decree *Inter Mirifica*.

The phenomenon of cyberbullying that occurs indicates that the perpetrators of crimes do not understand the main function and purpose of social communication facilities. Therefore, the author offers the content of the *Inter Mirifica* decree as one of the efforts to prevent cyberbullying. According to the author, the values contained in the *Inter Mirifica* Decree can rebuild the awareness of the faithful and all people about the main functions of communication media.
